

# **Privacy Policy**

Effective Date: August 26, 2025

This Privacy Policy (this "Privacy Policy") covers the information practices of Livingston Street Capital, LLC's ("Livingston," "we," "us" or "our") websites available at <a href="https://livingstonstreetcapital.com/">https://livingstonstreetcapital.com/</a> (the "Site"). Livingston believes strongly in protecting your privacy and the confidentiality of your personal information. We acknowledge that you may have privacy and security concerns with respect to the information we collect, use, and disclose to third parties. As a result, we have developed this Privacy Policy.

**PLEASE REVIEW THIS PRIVACY POLICY CAREFULLY**. By using the Site, you accept the terms of this Privacy Policy and our <u>Terms of Service</u>, confirm that you are not located outside the United States, and consent to our collection, use, disclosure, and retention of your information as described in this Privacy Policy. We currently only accept business and Site visitors within the United States.

## 1. INFORMATION WE COLLECT

Livingston collects personal information from you, which may include information you provide to us and information that is automatically collected about your computer hardware and software and how you use the Site when you access the Site.

## Information You Provide

• Where you contact us: If you contact us via the Site, we may collect your name, company name, e-mail address, and any additional information you provide when you contact us.

## Information Collected Automatically

In addition, information about your computer hardware and software is automatically collected by Livingston when you use the Site. This information may include: your IP address, browser type, domain names, access times, referring website addresses, and other technical information such as protocol status and substatus, bytes sent and received. We may also collect information about how you interact with the Site. This information is used by us for our business purposes, including for the operation and improvement of the Site, for technical troubleshooting, to maintain quality of the Site and to provide general statistics regarding use of the Site.

## Cookies and Other Information Collection Tools

What are cookies? A cookie is a small file containing a string of characters that is sent to your computer when you visit a website or use an online service. When you visit the

website or use the service again, the cookie allows that website or online service to recognize your browser or device. Cookies may store unique identifiers, user preferences, and other information.

Duration of Cookies. We may use "session cookies" or "persistent cookies." Session cookies are temporary and expire once you close your browser or once your session ends. Persistent cookies remain on your device for much longer or until you or your browser erase them. Persistent cookies have varying durations that are dependent on their expiration date.

Why do we use them? Cookies help us improve the Site by providing us with information about which parts of the Site are most popular, enabling us to analyze technical and navigational information about the Site, and helping us to detect and prevent fraud. We also use cookies and other data collection tools (such as web beacons and server logs) to help improve your experience with the Site.

How do I control cookies? Web browsers allow some control of most cookies through the browser settings. Some web browsers provide settings that allow a user to reject cookies or to alert a user when a cookie is placed on the user's computer, tablet, or mobile device. # PURPOSE FOR COLLECTION, USE AND DISCLOSURE OF PERSONAL INFORMATION

Livingston may use the information we collect for any of the following purposes:

- To provide the Site to you and to improve the Site;
- To create and manage your account with Livingston;
- Establishing and maintaining communications with you;
- Where you have requested information from Livingston, assisting you in the completion of your request and the assessment of your eligibility for any such request;
- Responding to your inquiries about the Livingston's properties or services;
- Managing, and making available information about, your investment with Livingston;
- For security, to detect fraud, suspicious or other illegal activities, and for archival and backup purposes in connection with the provision of the Site;
- For our business purposes, such as identifying Site usage trends, compiling statistics for analysis of the Site and our business, audits, enhancing our Site, improving our services;
- As we believe to be necessary or appropriate: (i) under applicable law; (ii) to comply with legal process; (iii) to respond to requests from public and government authorities; (iv) to enforce this Privacy Policy and our Terms of Service; (v) to

protect our operations; (vi) to protect our rights, privacy, safety or property, and/or that of you or others; and (vii) to allow us to pursue available remedies or limit the damages that we may sustain.

## 3. DISCLOSURE OF INFORMATION TO OTHERS

We may disclose your information to the following third parties:

- With Third Party Service Providers Performing Services on Our Behalf. We share your information with our service providers to perform the functions for which we engage them. For example, we may use third parties to host the Site or assist us in providing functionality on the Site, provide data analytics on the Site and send out marketing or informational materials.
- For Legal Purposes. We also may share information that we collect from users as needed to enforce our rights, protect our property, or protect the rights, property, or safety of others, or as needed to support external auditing, compliance, and corporate governance functions. We will disclose personal information as we deem necessary to respond to a subpoena, regulation, binding order of a data protection agency, legal process, governmental request, or other legal or regulatory process. We may also share personal information as required to pursue available remedies or limit damages we may sustain.
- Changes of Control. We reserve the right to transfer or assign the information that
  we have collected from users in connection with a corporate transaction, such as a
  divestiture, merger, consolidation, or asset sale, or in the unlikely event of
  bankruptcy.

Livingston does not share your personal information with third parties for those third parties' direct marketing purposes.

#### 4. LINKS TO EXTERNAL WEBSITES AND ONLINE SERVICES

Our Site may contain links to third-party websites and online services. Any access to and use of such third-party websites and online services is not governed by this Privacy Policy but is instead governed by the privacy policies of those third-party websites and online services, and we are not responsible for the information practices of such third-party websites and online services.

## 5. SMS TERMS, CONDITIONS, AND PRIVACY DISCLOSURE

By providing your phone number and clicking "Submit" online, you agree to our <u>Terms of Service</u> and <u>Privacy Policy</u>, and authorize us to initiate sales calls, text messages, and prerecorded voicemails to the number provided using an automated system. Your consent is not a condition of purchasing any property, goods, or services, and you may choose to do business with us over the phone instead. Message and data rates may apply. Message frequency may vary.

# Privacy Assurance

We are committed to protecting your privacy. Phone numbers collected for SMS consent will not be shared with third parties or affiliates for marketing purposes. All communications are used solely for the purposes outlined during the consent process.

# Types of SMS Communications

By opting in, you may receive text messages from Livingston Street Capital or any Allure Lifestyle Community related to sales or employment requests. These may include updates, reminders, or other relevant information.

# Message Frequency

Message frequency may vary depending on the type of communication. For example, up to 5 SMS messages per week may be received related to inquiries.

# Message and Data Rates

Standard carrier messaging and data rates may apply for both incoming and outgoing messages, depending on your mobile provider and plan. Fees may also vary for international messaging.

# Opt-In Process

Customers can opt in to SMS messaging during a call initiated or form completed via our website. During the call, the representative will request consent using the following statement:
